## **Foster Agreement**

- ➔ FRN will supply food, litter, cat boxes, bedding and toys if needed.
- ➔ During the foster program you must report weekly to the Director about the progress and condition of the fostered cat(s) or kitten(s);
- ➔ If you can no longer take care of the fostered cat(s) or kitten(s), you must return it to the FRN; you may not move the fostered cat(s) or kitten(s) to another foster;
- ➔ You will be expected to work with the Director to make arrangements for veterinary services. Veterinary services for fostered cat(s) or kittens are the financial responsibility of FRN. Unless veterinary services are authorized in advance by FRN, these expenses will not be reimbursed;
- ➔ FRN reserves the right to make unannounced visits to determine that proper care is being given to the fostered cat(s) or kitten(s);
- ➔ Although you, the foster parent, are encouraged to let potential adopters meet the cat(s) or kitten(s), all adoptions are subject to the FRN adoption process and approval.
- ➔ You will not add to the number of animals owned or fostered without notifying FRN in advance.
- ➔ You will not exceed the total legal limit of animals (including the fosters) allowed in your town or county
  
- ➔ You understand and agree that you will adhere to and comply with all relevant zoning and animal control codes and ordinances whether local county or state.
